NOTE: The referenced 144 A (975733502) and Reg S (975733601) are in interim facilities only.

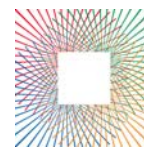

Cancellation: Cancellations for both of the above interim CUSIPs will not be permitted until after the "Certificate of Payment" of the underlying shares with respect to the Offered GDSs is listed locally.
