**Aiful Corporation** announced a 50% stock split in Japan payable to holders of record as of <u>March 31, 2005</u> (local record date). The payable date in Japan is expected to be <u>May 23, 2005</u>. Common shares to be issued as a result of this stock split will trade on a "when–issued" basis in Japan.

It is anticipated that the aforementioned corporate action will have the following effects on the Aiful Corporation ADS program:

One new Aiful ADS for every two ADSs held will be paid to holders of record March 30, 2005. (A 3 for 2 stock split).

The ADS payable date for the split is expected to be May 27, 2005.

The ADS program will be closed for all ordinary share deposits from <u>March 31, 2005</u> to <u>June 2, 2005</u>. The ADS program will be reopened on <u>June 3, 2005</u>.

The ADS program will trade with due-bills from March 28, 2005 to close of business May 27, 2005.

The settlement date for due-bills is expected to be **June 2**, **2005**.
