Owners of Global Depositary Receipts ("GDRs"), of Apollo Hospitals Enterprise Limited (the "Company") have been previously notified that BNY Mellon as Depositary has terminated the GDR facility. As the period for GDR holders to cancel their GDRs has expired, BNY Mellon has accordingly sold all remaining deposited securities representing outstanding GDRs of the Company. The sales of the deposited securities were subject to an Indian withholding tax of 43.68% of the gross proceeds from the sales.

GDR holders of Apollo Hospitals Enterprise Limited. are now entitled to receive the net cash proceeds from the sale of the Apollo Hospitals Enterprise Limited ordinary shares on a pro-rata basis.

Apollo Hospitals Enterprise Limited GDR holders will be required on a mandatory basis to surrender their GDRs to BNY Mellon for cancellation and exchange. Holders of GDRs in brokerage accounts will have their GDRs automatically exchanged for the cash proceeds.
