Cash Distribution Resulting from the Sale of Acen Corporation Shares

Ayala announced a distribution of Acen Corporation ("Acen") to its shareholders. The shares were allocated as follows: 3 Acen shares were issued for every 1 Ayala Share held as of local record date May 27, 2022. BNYM Mellon received the Acen Shares on July 28, 2023.

The Acen shares were not registered under the United States Securities Act of 1933, therefore we were not permitted to pass the shares on to the holders of American Depositary Receipts ("ADRs"). As a result, BNY Mellon sold the shares in the local market and the proceeds from the sale will be distributed to ADR holders.

In addition, Acen Corporation paid a cash dividend as of local record date August 22, 2023. Below is the breakdown of this cash dividend payment per Ayala ADS:

The distribution of the shares of Acen Corporation was considered a dividend in the Philippines and was subject to deduction of 25% Philippine withholding tax. The distribution of shares was reduced from 3 Acen shares for every 1 share of Ayala to 2.25 Acen shares for every 1 share of Ayala held as of the local record date to pay the tax.
