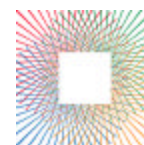

We have been informed that Systex Corporation ("Systex") and Sysware Corporation ("Sysware") are scheduled to merge with the effective date of January 1, 2007. At the request of Systex Corporation, the Global Depositary Receipts ("GDRs") Facilities pursuant to the Deposit Agreement, dated June 23, 2000, between Systex Corporation and The Bank of New York, as Depositary, will be terminated effective on the opening of business day, **January 2, 2007** (New York time) ("Termination Date"). As a result of the Merger, owners of Systex Corporation GDSs, will be entitled to receive the net proceeds of the sale of the Sysware Corporation common stock. Further information of such sale will follow.

If you surrender GDSs for the purpose of withdrawing the underlying common stock of Systex Corporation before the Termination Date, please note that applicable fees shall apply pursuant to the Deposit Agreement.

If you wish to receive payment of the net proceeds of the sale of Sysware Corporation common stock, please do not surrender your GDSs at this time. The Depositary will send a separate notice with instructions to surrender your GDSs after the completion of the sale of Sysware Corporation common stock.

Terms used in this Notice and not otherwise defined therein shall have the meanings set forth in the Deposit Agreement.
