The Bank of New York Mellon, at the direction of Moko Social Media Ltd. (the “Company”), is announcing a ratio change on the Depositary Receipt (“DR”) program from 1 Depositary Share (“DS”) representing 20 Ordinary shares to 1 DS representing 40 Ordinary shares.

The ratio change will result in a reverse split on the Moko Social Media DSs on the basis of 1 new DS for every 2 old DSs held.

Effective **June 16, 2014**, DS holders of Moko Social Media are required on a mandatory basis to surrender their old DSs for cancellation at the rate of two (2) “OLD” DSs (CUSIP# 608458105) for one 1 “NEW” DS (CUSIP# 608458204). Only whole DSs will be distributed. BNY Mellon will attempt to sell any fractional DSs and distribute the cash proceeds.
