## Reverse Stock Split

Please be advised that Outokumpu OYJ has announced a reverse stock split on its ordinary shares in the local market of one (1) new ordinary share for every twenty five (25) existing ordinary shares held to holders of record on June 19, 2014.

As a result, BNY Mellon will effect a 1 for 25 reverse stock split on the DR program. Effective June 23, 2014, DR holders of Outokumpu OYJ are required on a mandatory basis to surrender their DRs for cancellation and exchange twenty five (25) "Old" DRs (CUSIP 69011W101) for one (1) "New" DRs (CUSIP TBD). Only whole DRs will be distributed. DR holders will be charged a cancellation fee of \$0.048 per DR surrendered.
