BNY Mellon has been advised by Naspers Limited ("Naspers") that it has proposed the listing of a new global consumer internet group ("NewCo") on Euronext Amsterdam and the Johannesburg Stock Exchange by way of introduction on conjunction with the Capitalizations Issue as described in the Naspers Circular dated May 29, 2019. Naspers shareholders will be entitled to receive one M ordinary share in the capital of Naspers ("Naspers M Share") for each Naspers N share held as of July 29, 2019. Each Naspers M Share will be automatically converted into one N ordinary share in the capital of NewCo ("NewCo N Share"). BNY Mellon, as depositary, will participate in the Naspers M Share Capitalization Issue on behalf of American Depositary Share ("ADS") holders of Naspers.

ADS holders of Naspers will be entitled to "new" NewCo ADSs at a rate of one (1) NewCo ADS for every one (1) Naspers ADS held as of July 19, 2019. The ADS ratio of the NewCo ADS program will be 5 ADSs: 1 NewCo N Share.
